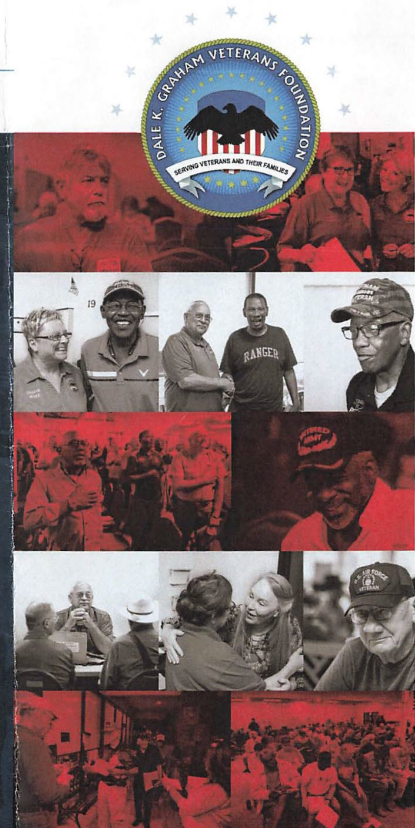

The Foundation offers an expansive support network to connect Veterans with critical resources for food, shelter, and emergency assistance.



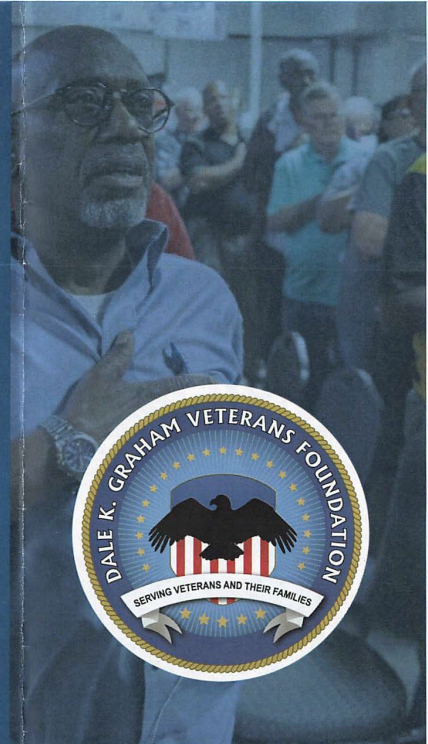
